

# Your Guest Card - Pfronten Card

- Under the motto "allgäumobil im Schlosspark" the Pfronten Card enables you to use the bus and railway network with approx. 500 km and 174 stops for your activities and excursions for free. A timetable is available at the Tourist Information.
- Free access to the "Schlosspark WIFI": free and unlimited.
  Hotspots are marked in the city map.
- Free purchase of map material from Pfronten Tourismus (e.g.: adventure guide, city map, winter leisure map, Pfronten Tour Tips).
- Discount on hiking- & cycling maps with tour descriptions, available in the Tourist Information of Pfronten).
- Discount on entrance fees to the leisure facilities
   (e.g.: swimming pools, mountain railway, ice rink Pfronten,
   20% discount for Tickets in "Festspielhaus Neuschwanstein",
   Butterfly garden Pfronten, Waldseilgarten Pfronten, etc.).
   No additional discount on already discounted services.







## Bundesmeldegesetz (Federal Citizen's Registration Act):

**Bundesmeldegesetz**, §29: All accomodation establishments are required to report a guest's duration of stay - regardless of the company's size or where the organisation is located.

#### **Resort Tax:**

The resort tax is used to cover part of the expenses for the acquisition, expansion, improvement, renovation and maintenance of the tourism facilities and grounds as well as the infrastructure, cultural activities and events necessary for this purpose.

### **Explanation of the duty to pay resort tax:**

§1 Statute for imposing a resort tax in the municipality of Pfronten: "People who stay in the spa region of Pfronten for spa and recreational purposes, whose main residence is not located in the region within the meaning of the registration act, and who are offered the opportunity to use the spa facilities and participate in the events on offer, are obligated to pay a resort tax. This duty does not depend on whether and to what extent services provided by organisations and local areas which offer resort facilities are actually used."

### Calculations of resort tax in resort area I and resort area II:

Resort Area I: 2,40 € (from 16 years of age) & 1,50 € (from 7 to 16 years).

Resort Area II (Districts Kappel und Rehbichl): 1,80 € (from 16 years of age) & 1,20 € for people from 7 to 16 years of age.

From 01.11. to 15.12. only 50% of the resort tax amount is charged per day in all spa areas. The amount of the resort tax is reduced by half upon presentation of a severe disablement card with a disa bility level above 80 (GdB 80). If a "B" for Begleitung (accompanying person) is indicated in the card, the accompanying person shall be exempt from the resort tax.

Business stays by guests are exempt from a resort tax upon presentation of a certificate from their employer (for stays of one night upon proof by showing a business card). For further information about the resort tax, please visit: www.rathaus.pfronten.de
